Dear Parents,

What a week it has been! We have certainly learned how to think on our feet and to respond rather than react. I would really like to thank everyone for their ongoing support and kind words when things are not easy or don't go to plan! At this point in time we will continue to plan as we normally would but we know that things can certainly change overnight.

Due to the fact that many of the sites we would have visited have been closed due to Covid and the concerns we have around taking the children to the city at this point in time, we have chosen to cancel the city camp. We are now in the process of finding a different campsite (rural or beach) for later in the year. I know this will cause relief for some and disappointment for others but we will see it as a postponement.

This week I have spoken to the children about the importance of being kind and also using our manners, for example, please and thank you and using people's names when we speak to them. I have also reminded the students that name calling is not accepted at this school, even if someone calls them a name first. Can you please reiterate this with your child at home and remind them to see a teacher if something happens that makes them feel upset or hurt. This way we can deal with issues immediately and get all sides of the incident.

I have contacted Hume Council regarding the situation with parking outside the school in Macedon Street. It continues to be an issue with cars backing in to the point they are on the footpath. I will keep you posted on the outcome but please ensure you are acting safely and responsibly.

The other issue is around parents waiting on the footpath after school and blocking the way for students leaving the school. Social distancing rules still apply and it is becoming dangerous for the children who need to walk on to the gravel into the path of cars because the footpath is being blocked by adults. The leaders on gate duty have been advised to move people on if this is the case.

Congratulations to our bike riders. There have been two incidents this week that have been brought to my attention where they were concerned about one of their friends and looked after each other They were very responsible in the way they handled each situation and I am very proud of them.

In 2019 we did some major fundraising to build a bike shelter. We have finally been able to find a reliable builder who did an awesome job of putting it altogether. Thank you to everyone who helped in raising this money. If you have any ideas for 2021 fundraising I am all ears!! Please contact me at your earliest convenience.

Gospel

Mark 1:40-45

Reflection:

Again, in this gospel we find Jesus moved with pity. Leprosy was a living death: the sufferer was isolated from family and community, and had to cry out 'Unclean, unclean!' when anyone approached. Touching the leper made Jesus ritually unclean also. There are no lengths to which Jesus will not go to help this man. He touches him, speaks to him, and gives him his freedom to be fully human again.

The 14th February is celebrated as Valentine's Day. I assume you all know the history of St Valentine, a priest in Rome who was in prison waiting to be martyred.

"There are many legends behind Saint Valentine. One is that in the 3rd century AD it is said that Valentine, defied the order of the emperor Claudius and secretly performed <u>Christian weddings</u> for couples, allowing the husbands involved to escape conscription into the pagan army. This legend claims that soldiers were sparse at this time so this was a big inconvenience to the emperor. The account mentions that in order "to remind these men of their vows and God's love, Saint Valentine is said to have cut hearts from parchment", giving them to these <u>persecuted Christians</u>, a possible origin of the widespread use of hearts on St. Valentine's Day.

Another legend is that Valentine refused to sacrifice to pagan gods. Being imprisoned for this, Valentine gave his testimony in prison and through his prayers healed the jailer's daughter who was suffering from blindness. On the day of his execution, he left her a note that was signed, "Your Valentine"."

Hence there is a wonderful opportunity for couples to ponder their love, commitment to each other and their relationship built upon love and fidelity.

Yes, we all know the significance of the 'heart' as a sign of love. This little prayer from Sunday's Mass is another example of the love of God for us and once again, one can substitute the name of your loved one as an expression of the protection and strength you find in them.

Be my protector, O God,

a mighty stronghold to save me.

For you are my rock, my stronghold!

Lead me, guide me, for the sake of your name.

May the love of God for each one of us be seen as 'Your Valentine' who watches over and protects us, standing by as the rock to support and uphold us each day.

FINANCIAL ASSISTANCE

INFORMATION FOR PARENTS

Every Victorian child should have access to the world of learning opportunities that exist beyond the classroom. The Camps, Sports and Excursions Fund helps ensure that no student will miss out on the opportunity to join their classmates for important, educational and fun activities. It is part of making Victoria the Education State and the Government's commitment to breaking the link between a student's background and their outcomes.

CAMPS, SPORTS & EXCURSIONS FUND (CSEF)

School camps provide children with inspiring experiences in the great outdoors. Excursions encourage a deeper understanding of how the world works while sports teach teamwork, discipline and leadership. All are a part of a healthy curriculum.

CSEF is provided by the Victorian Government to assist eligible families to cover the costs of school trips, camps and sporting activities.

If you hold a valid means-tested concession card or are a temporary foster parent, you may be eligible for CSEF. A special consideration category also exists for asylum seeker and refugee families. The allowance is paid to the school to use towards expenses relating to camps, excursions or sporting activities for the benefit of your child.

The annual CSEF amount per student is:

- · \$125 for primary school students
- \$225 for secondary school students

HOW TO APPLY

New applicants should contact the school office to obtain a CSEF application form or download from the website below.

If you applied for CSEF at your child's school last year, you do not need to complete an application form this year unless there has been a change in your family circumstances.


You only need to complete an application form if any of the following changes have occurred:

- new student enrolments; your child has started or changed schools this year
- changed family circumstances; such as a change of custody, change of name, concession card number, or new siblings commencing this year.

Check with the school office if you are unsure.

CSEF ELIGIBILITY

Below is the criteria used to determine a student's eligibility for the Camps, Sports and Excursions Fund (CSEF).

Criteria 1 - Eligibility

To be eligible* for the fund, a parent or legal guardian of a student attending a registered Government or nongovernment Victorian primary or secondary school must:

- · on the first day ofTerm one, or;
- on the first day ofTerm two.
- a) Be an eligible beneficiary within the meaning of the State Concessions Act 2004, that is, be a holder of Veterans Affairs Gold Card or be an eligible Centrelink Health Care Card (HCC) or Pensioner Concession Card (PCC) holder, OR
- b) Be a temporary foster parent, and;
- c) Submit an application to the school by the due date.
- * A special consideration eligibility category also exists. For more information, see:

Parents who receive a CarerAllowance on behalf of a child, or any other benefit or allowance not income tested by Centrelink, are not eligible for the CSEF unless they also comply with one of (a) or (b) above.

Criteria 2 - Be ofschoolage andattend schoolinVictoria

School is compulsory for all Victorian children aged between six and 17 years of age inclusive.

For the purposes of CSEF, students may be eligible for assistance if they attend a Victorian registered primary or secondary school. Typically, these students are aged between five and 18 years inclusive.

CSEF is not payable to students attending pre-school, kindergarten, home schooled, orTAFE.

EligibilityDate

For concession card holders CSEF eligibility will be subject to the parent/legal guardian's concession card being successfully validated withCentrelink on the first day of either term one (27th January 2021) or term two (19th April 2021).

PAYMENT AMOUNTS

CSEFpayment amount

The CSEF is an annual payment to the school to be used towards camps, sports and/or excursion expenses for the benefit of the eligible student.

- Primary school student rate: \$125 per year.
- Secondary school student rate: \$225 per year.

The CSEF is paid directly to your child's school and will be allocated by the school towards camps, sports and/or excursion costs for your child.

For ungraded students, the rate payable is determined by the student's date of birth. For more information, see: www.education.vic.gov.au/about/programs/Pages/csef.aspx

Year 7 government school students who are CSEF recipients are also eligible for a uniform voucher. Secondary schools are required to make applications on behalf of parents so please register your interest at the school.

HOW TO COMPLETE THE APPLICATION FORM

NOTE:ALLSECTIONSMUST BE COMPLETEDBYPARENT/LEGALGUARDIAN

- Complete the PARENT/LEGALGUARDIAN DETAILS section.
 - Make sure that the Surname, First Name, and Customer Reference Number (CRN) details match those on your concession card. You will also need to provide your concession card to the school.
 - If you are claiming as a Foster Parent or a VeteranAffairs Pensioner, you will need to provide a copy of documentation confirming your status as a temporary Foster Parent or provide your VeteransAffairs Pensioner Gold card to the school.
- 2. Complete the STUDENT/S DETAILS section for students at this school.
- Sign and date the form and return it to the school office as soon as possible. The CSEF program for 2021 closes on 25th June 2021.

CSEF payments cannot be claimed retrospectively for prior years.

Dear parents, guardians and carers

Re: Nationally Consistent Collection of Data on School Students with Disability (NCCD)

Every year, all schools in Australia participate in the Nationally Consistent Collection of Data on School Students with Disability (NCCD). The NCCD process requires schools to identify information already available in the school about supports provided to students with disability. These relate to legislative requirements under the *Disability Discrimination Act 1992* and the Disability Standards for Education 2005, in line with the *NCCD guidelines* (2019).

Information provided about students to the Australian Government for the NCCD includes:

- year of schooling
- · category of disability: physical, cognitive, sensory or social/emotional
- level of adjustment provided: support provided within quality differentiated teaching practice, supplementary, substantial or extensive.

This information assists schools to:

- formally recognise the supports and adjustments provided to students with disability in schools
- · consider how they can strengthen the support of students with disability in schools
- develop shared practices so that they can review their learning programs in order to improve educational outcomes for students with disability.

The NCCD provides state and federal governments with the information they need to plan more broadly for the support of students with disability.

The NCCD will have no direct impact on your child and your child will not be involved in any testing process. The school will provide data to the Australian Government in such a way that no individual student will be able to be identified – the privacy and confidentiality of all students is ensured. All information is protected by privacy laws that regulate the collection, storage and disclosure of personal information.
