# <mark>Newsl</mark>etter

I would like to draw your attention to the **OLMC Complaints Handling Policy** which can we found on the school's website. In particular I wish to reiterate that parents should not be contacting other parents regarding issues that arise at school. The following is an excerpt from the policy:

Raise the matter directly with the relevant staff member first where appropriate. If the matter involves your child or an issue of everyday class operation, contact the staff member concerned, preferably by email, explaining the nature of your concern and request a telephone conversation or meeting. The teacher will acknowledge the email within two working days. The staff member may be able to respond to your complaint by return email or telephone with a satisfactory outcome. At times, parties may be assisted to resolve a misunderstanding, miscommunication or lack of clarity through the support of another person, such as another member of staff or the principal.

In making a complaint, Our Lady of Mount Carmel Primary School requests and expects that the Complainant will:

- raise the concern or complaint as soon as possible after the issue has arisen,
- communicate and respond in ways that are constructive, fair and respectful
- provide complete and factual information about the concern or complaint
- observe confidentiality and a respect for sensitive issues
- act in good faith to achieve an outcome acceptable to all parties
- have realistic and reasonable expectations about possible outcomes/remedies.

Under no circumstances should you approach another student while in the care of the school to discuss the issue or chastise them.

Direct contact with parents to resolve the matter is also discouraged if the complaint pertains to issues or incidents that have arisen at the School.

Earlier today, the Victorian Government announced that existing COVIDSafe measures in schools and early childhood settings would continue until the end of Term 1.

Rapid antigen surveillance testing will continue until the end of Term 1. We are expecting that the delivery of rapid antigen tests (RATs) for weeks five and six will start from today, with additional RATs to be delivered in the coming weeks.

The testing settings will remain the same, with all primary and secondary school students and staff, early childhood education and care staff, and children aged 3–5 recommended to test at home twice a week, while students and staff at specialist schools are recommended to test five days a week.

RATs have proved an important COVIDSafe tool to help reduce the number of COVID-19 cases and ensure our schools are as safe as possible. Their use will remain voluntary for staff and students, but is strongly encouraged.

#### **Gospel Reflections**



In 1967, John Lennon was onto something pretty good in proclaiming "All You Need is Love!". A hit single in no time. Many before, and many after continued to share this same message in their lyrics and fittingly, on Monday this week, love was definitely in the air with the celebration of Valentine's Day. A largely commercial day that twelve months ago was hampered by a 'circuit-breaker' lockdown in Melbourne. Whilst for many of us we can be forgiven for going down the rabbit hole of flowers and chocolates on this day, it is also a timely opportunity to centre

our minds on the unconditional love offered to us from God, through Jesus his Son.

From the Bible, we read that "God loved the world so much that he gave his only Son so that we might have eternal life" (John 3:16). Countless times we hear of stories of Jesus' demonstration of love to the marginalised, outcast, sick, blind and poor. We also hear of several teachings from Jesus that point us towards the unconditional love of his Father in heaven, the Prodigal Son is an example of this. However, there is no greater example of Jesus' love for us that in the greatest commandment he leaves for us: "Love the Lord God with all your heart, and with all your soul and all your mind...and love your neighbour as you love yourself" (Matthew 22:36). Just imagine, given the current local and global crises that continue to plague us, if we were to apply this teaching: To love one another as Jesus loves. What a world we could be! Luke's Gospel from this Sunday echoes this sentiment to love, to give generously and show compassion to one another.

All of this done for no self-desire of a return, but instead for an unknown reward that awaits us.

Finally, still on the theme of love, I would like to close with the above image, and text from St Paul's letter to the Corinthians. If I was to take up a survey, I'm pretty sure that many of you reading this featured this reading at your wedding. I did too! In reflecting upon the reading, I set you the challenge to consider, who is it in your life that demonstrates this love that is patient, kind, not envious or boastful? Who shows you this love that honours you and is not easily angered? Whose love in your life keeps no record of wrongs but rejoices in the truth. Whose love always protects, always trusts, always hopes and perseveres. Whose love never fails you? Maybe this describes the love that you continue to demonstrate to your world! Not as simple as it sounds, to live a life of love, but so many wonderful examples and blueprints of how to do so. According to John Lennon, "It's easy....All you need is love...Love is all you need."

May we continue to live God's love in our lives.

## INFORMATION FOR PARENTS

Every Victorian child should have access to the world of learning opportunities that exist beyond the classroom. The Camps, Sports and Excursions Fund helps ensure that no student will miss out on the opportunity to join their classmates for important, educational and fun activities. It is part of making Victoria the Education State and the Government's commitment to breaking the link between a student's background and their outcomes.

TO BE ELIGIBLE TO RECEIVE THE CSEF FUND PAYMENTS PARENTS MUST BE THE HOLDER OF A GOVERNMENT CONCESSION CARD. CONTACT THE SCHOOL OFFICE FOR MORE DETAILS

# CAMPS, SPORTS & EXCURSIONS FUND (CSEF)

School camps provide children with inspiring experiences in the great outdoors. Excursions encourage a deeper understanding of how the world works while sports teach teamwork, discipline and leadership. All are a part of a healthy curriculum.

CSEF is provided by the Victorian Government to assist eligible families to cover the costs of school trips, camps and sporting activities.

If you hold a valid means-tested concession card or are a temporary foster parent, you may be eligible for CSEF. A special consideration category also exists for asylum seeker and refugee families. The allowance is paid to the school to use towards expenses relating to camps, excursions or sporting activities for the benefit of your child.

The annual CSEF amount per student is:

- · \$125 for primary school students
- · \$225 for secondary school students

#### HOW TO APPLY

New applicants should contact the school office to obtain a CSEF application form or download from the website below.

If you applied for CSEF at your child's school last year, you do not need to complete an application form this year unless there has been a change in your family circumstances.

You only need to complete an application form if any of the following changes have occurred:

- new student enrolments; your child has started or changed schools this year.
- changed family circumstances; such as a change of custody, change of name, concession card number, or new siblings commencing this year.

Check with the school office if you are unsure.
